A PROCLAMATION

By the Governor

WHEREAS, Edwin F. Flowers was born on April 26, 1930, in New Manchester, Hancock County, West Virginia, the son of the late Walter Edwin Flowers and Stella Marie Ulbright Flowers; and

WHEREAS, Edwin Flowers earned a Bachelor of Arts degree as a Phi Beta Kappa graduate of West Virginia University in 1953 and LLB in 1954; and

WHEREAS, Edwin Flowers served as president of the student body, president of his fraternity chapter, cadet colonel of the Air Force Reserve Officer Training, a member of the WVU Marching Band, and a member of the WVU championship debate team, while attending WVU; and

WHEREAS, Edwin Flowers was awarded Most Loyal Faculty and Staff Mountaineer in 1999 and was inducted into the Order of Vandalia, an award for the most loyal servants to West Virginia University, in 2000; and

WHEREAS, Edwin Flowers was assigned to active duty in the Judge Advocate General's Corps at Nellis Air Force Base in 1954; and

WHEREAS, Edwin Flowers was appointed as Commissioner of Welfare for the State of West Virginia in 1969 by the late Governor Arch Moore; and

WHEREAS, Edwin Flowers was appointed to the West Virginia Supreme Court of Appeals in 1975 and became United States bankruptcy judge for the Southern District of West Virginia in 1977; and

WHEREAS, Edwin Flowers was selected as vice president for institutional advancement at West Virginia University by E. Gordon Gee in 1983; and

WHEREAS, Justice Edwin Flowers, a committed and respected public servant and a devoted son, husband, father, grandfather, great-grandfather, brother, friend, colleague, and neighbor, passed away on January 27, 2022; and

WHEREAS, Justice Edwin Flowers is survived by his wife, Ellie Flowers; two daughters, Ann Flowers and Melissa (Ty) Newberry; grandchildren, Adam (Ashley) Flowers and Kathryn (Sean) Hendricks; great-grandchildren, Matthew Hendricks and Jack Flowers; and was preceded in death by his parents; son, John Flowers; and brothers, Ronald Flowers and Dale Flowers; and

WHEREAS, the citizens of the State of West Virginia, friends, and associates of Justice Edwin F. Flowers desire to recognize his dedicated public service to the Great State of West Virginia, and to acknowledge his valuable contributions to the State.

NOW, THEREFORE, I, JIM JUSTICE, by virtue of the authority vested in me as the Governor of the State of West Virginia, do hereby ORDER that, in commemoration of the distinguished life and service of West Virginia Supreme Court Justice Edwin F. Flowers, the United States and West Virginia State flags displayed at the Capitol Complex in Charleston, West Virginia, and at all State facilities throughout Hancock County, West Virginia, shall be lowered to half-staff from dawn to dusk on February 22, 2022, the day of services celebrating his life.
