A PROCLAMATION

By the Governor

WHEREAS, Barry Lester Cook was born on the Tenth day of May, Nineteen Hundred Forty-nine, in Williamson, West Virginia, the son of Lester H. Cook and Vicie Catron Cook; and

WHEREAS, Barry Cook graduated from Williamson High School in Nineteen Hundred Sixty-seven; earned his Bachelor of Science degree in Forest Management from West Virginia University in Nineteen Hundred Seventy-one; and received his Master of Business Administration from Duke University in Nineteen Hundred Ninety-four; and

WHEREAS, Barry Cook was a seasoned forester of Forty-five years and a military veteran; and

WHEREAS, Barry Cook was appointed by Governor Jim Justice to the position of Director, State Forester of the West Virginia Division of Forestry; and

WHEREAS, Director Cook served on executive committees and boards for various organizations prior to his appointment including, the Hardwood Manufacturing Association, the West Virginia Forestry Associations, Pioneer Southern Company, Coastal Lumber Company, Chocoyotte Country Club, and Gutchess Lumber; and

WHEREAS, Director Cook and his wife Donna were former owners and operators of Delightfully Yours Bakery and Cafe in Beckley; he was an associate member of the United Methodist Temple in Beckley and a member of Antioch Baptist Church, Enfield, NC; and

WHEREAS, Director Barry Cook, a committed and respected public servant and a devoted son, husband, father, grandfather, friend, and neighbor, died on the Ninth day of May, Two Thousand Twenty; and

WHEREAS, Director Barry Cook is survived by his wife, Donna Shearin Cook; daughters, Tiffany Cook (Nic) Ntanos and Maggie-Jean Catron Cook; sons, Adam Barry (Lauren) Cook, Tyhler James-Lester Cook, and Logan Bryce-Elliott Cook; grandchildren, Hayley K. (Michael) Belles, Lydia Grace Johnson-Cook, Gregg Cook, Nicholas Cook, and Charlie; sister, Kay Cook Powers; mother-in-law, Linda K. Wrenn; brother-in-law Marvin (Audrey) Shearin; sister-in-law Paula S. (Artie) Elias; and several nephews and nieces; he was preceded in death by his parents; and brothers, Rolfe A. Cook and Peter C.
